General Membership Meeting Minutes

March 15, 2017 6:30pm

North Highline Fire District, Station 18

President Mark Thompson called the meeting to order at 6:39pm.

- I. Welcome North Highline Fire District Battalion Chief Paul Frey
 - Chief Frey welcomed everyone to Station 18
 - Two fire stations, North Highline is now 3.5 sq miles, used to be 18 miles when he started with the district back in 1983
 - North Highline has a contract with Burien to share their Chief, Battalion Chiefs and some administrative staff.
- II. Presentation Washington State Fire Marshall Chuck Duffy
 - Chuck relayed greeting from his boss, State Patrol Chief John Batiste
 - Chuck was the first Washington State Fire Marshall to come from the Washington State Fire service. The Marshalls before him were the State Insurance Commissioner or people from out of state.
 - The Washington State Fire Marshall Office is part of the Washington state patrol
 - Chuck has been Fire Marshall for the last 7 years. When he took over he refocused the office on serving the fire service.
 - Finances are a big challenge. Need a dedicated fund for the Fire Training Academy and the State Fire Marshalls office and need everyone in the fire industry to lobby for funding for them so they can serve us.
 - Big challenges at the fire training academy
 - i. Culture needed to change, move forward and serve the fire service
 - ii. Facilities 2013 master plan, replace the burn buildings
 - When he took over as Marshall he revamped the fire training academy
 - Now they have a full time safety officer he is a resource for all our agencies
 - They completed the SCBA building and have 4 new fire engines
 - They always comply with all EPA regulations which is very expensive
 - 7.5 million is all they have so far towards the 15 mil they need and that is a loan
 - Chuck will be retiring at the end of the Month. The State Patrol Chief will make the decision on his replacement. There are 16 applicants for his position now.
