I. Committee Reports

A. Treasures Report – Camille Staczek

- Chris reported that Camille informed him that she sent invoices to districts that attended the banquet and haven't paid yet
- The bookkeeper is in process of sending out membership renewals this week

B. WFCA Region 6 Report - Chris Elwell

- They had a meeting in July health care is doing well, they are at 94% and under budget by \$500,000, they have had fewer claims but the claims they did get where more expensive, they are recommending for 2017 no premium increases, there was a small increase on the dental program but they chose to cover this with their reserves instead of raising premiums
- Two motions passed by health care committee, benefit expansion for autism spectrum disorder and the second provider network consolidation (mostly pertains to SW Washington and their network providers)
- WFCA is going through a salary survey to make sure they are paying their staff appropriately
- WFCA owns their office building, they just had the roof replaced, building is in good condition
- They are currently working on 2017 legislative issues
- Firefighter technical review, 1 case reviewed was large city that had a large natural gas explosion with one minor finding
- On the WFCA web site there is now a page for best practices, they are encouraging departments to send in their best practices
- Roger and the president will be meeting with L&I to try to reduce the L&I premium amounts including a return to work program
- Conference coming up in October in Yakama

C. Emergency Management Report – Jim Fossos

- Mark went to emergency management meeting, they had communication issues during Cascadia
 Rising, a city can circumvent the county when requesting resources, trying to get the cities to work
 through the county for request for resources.
- Had a discussions about the budget short fall for King County air and dive teams and it was determined that KCFCA should not write a letter on this issue. If they have a real need they will let us know and we can send a letter later if determined.
- They sent out a survey about Cascadia Rising but a large portion of recipients couldn't open it. They are going to resend it, Mark will send it to all our members. They want everyone to fill it out even if they didn't participate.
